Dear Mr. Diallo,

After a thoughtful scrutiny, the Grant Evaluation Committee has deemed the grant proposal ready for official submission to AUC. Hence, you are kindly requested to send your grant proposal officially to the AUC, three original hard copies and a 2 soft copies in two CD.

However, the Evaluation Committee has pointed out some critical issues which should be given due attention during implementation. These are the following:

Difference between continental regional and national training:

This has been clarified in the latest version of the proposal by adding a diagram as proposes by one member of the evaluation committee.

A clearer terminology was applied distinguishing the training in 1) regional and 2) continental is applied.

To enhance clarity and consistency working package in the latest version of the implementation plan, during inception phase and prior consultations with the partners will be refined.

Agricultural and hydrological drought outlook.

Here there would be a need of explaining which methodology, approaches and activities will be used for the creation of this agricultural and hydrological drought outlook.

Hence, it is required that, in the very early phase of implementation, this aspect will be fully clarified. To this aim, as also suggested by ACMAD, during the meeting on "Product definition" methods, tools and data will be fully harmonised to then contribute to the production of the continental bulletin.

Other aspects to be considered during implementation are to identify more <u>precisely target</u> users by service and include impact indicators in the logical framework.

Strengthen the Climate Change Assessment Service.

This seems to be a unique role for ACMAD to provide information which can be used in government policies on long term policy changes which will be required over a 20-30 year time scale, such as changes to cropping systems or areas for home building. It is expected that during implementation this area will be well covered.

Finally, ACMAD will have to submit all the **required administrative documentation** in a way that the application is complete (see complete list below).

- 2) 1 original full grant application document <u>with the signed and stamped originals</u> of all the mandates and other attests and certificates included plus 2 copies.
