  - b) Participated and contributed in the FA Capacity Building Meeting held on the 25<sup>th</sup> of April 2022. During the meeting between ACMAD, WMO and UK Met Office, we discussed on the Capacity Building part, and what ACMAD and UK Met Office will present on. The topics and presenters are shown in the concept note found below in the annexes.
- D1.2 Advise on and support linkages and coordination with SARCOF's and other initiatives in the Southern Africa Region:
  - a) Participated in the ACCOF3 on the 8<sup>th</sup> of April and ACCOF-4 on the 29<sup>th</sup> of April virtual meeting, and had also invited a lot of stakeholders and climate experts in the SADC region to register and join in the meeting. The turn up was still unsatisfactory, and I will have to share the concept notes for such events well in advance in the future, and make sure that participants will be able to log in to join. But at least an expert in Indigenous Knowledge on seasonal Forecasting joined in, and there was a fruitful discussion on involving such in the near future.
- D2.1 Support collection of data from SARCOF's on users' requirements in the SADC region for water, food and energy sectors.
- a) The Green book developed by CSIR, and completed in 2019 is basically an online planning support tool that provides quantitative scientific evidence on the likely impacts that climate change and urbanization will have on South Africa's cities and towns, as well as presenting a number of adaptation actions that can be implemented by local government to support climate resilient development.
- b) Users of the Green Book are guided through the research and evidence in a series of 11 story maps that explains the:
- Vulnerability of South African municipalities, settlements and neighborhoods
- The anticipated impact of a growing urban population under a medium and high growth scenario
- The changes projected for South Africa's climate under a low and high mitigation scenario
- The extent of hydro-meteorological hazards in South Africa, and the impact of a changing climate on these hydro-meteorological hazards
- The impact of a changing climate on South Africa's economy, agriculture, forestry and fisheries sector, surface water and groundwater

For each of the story maps, a detailed peer-reviewed technical report is included under the Methodology section.

Way forward, will be to develop storylines using the CSIR approach for all the Countries in the region, based on the Risk and Vulnerability Assessments carried out, and needs to be discussed further with CSIR, by ACMAD, WMO and CSIR.

- a) Familiarized myself with FOCUS Africa 2nd Stakeholders workshop in Tanzania, in order to understand their case studies and identify material which could be used for training in the region.

# FOCUS-Africa Week 30 May – 3 June 2022- South Africa Concept Note

# 1. Background Information

The <u>EU FOCUS-Africa (FA) H2020 project</u> that was started to be implemented in September 2020 aims to develop sustainable, tailored climate services to support improved climate-related outcomes in key climate-sensitive sectors – agriculture and food security, water, energy and infrastructure – across the Southern African Development Community (SADC) region. The project incorporates eight case studies in five southern African countries (South Africa, Malawi, Mozambique, Tanzania, and Mauritius) involving a wide range of enduses and users. The case studies illustrate how the use of climate science, information and products can maximize socio-economic benefits in the Southern Africa region and potentially in the whole of Africa.

Planning and organizing stakeholders' workshops, as part of the project's workpackage-1 activities, is instrumental for collecting inputs from internal and external entities that are engaged in the development of the FOCUS-Africa climate services. Workshops will be organized almost every 8 months featuring each time one of the countries involved in the case studies. Depending on the travel limitation imposed by the COVID pandemic, the workshops will be hosted virtually or by the targeted country.

The First FA Stakeholders' Workshop was focused on South Africa and took place virtually. It was comprised of Internal workshop (30 November – 1 December 2020) and external stakeholder workshop (9 December 2020) with a focus on related food security case study to incentivize a wider local participation. The Second FA Stakeholders' Workshop was debuted by a one-day General Assembly virtual meeting that brought together the FA consortium members, close partners, AB members, EU officers and H2020 sister projects coordinators. This was followed by a two-day virtual FOCUS-Africa external stakeholders meeting focusing on the case studies in Tanzania for energy, infrastructure, and food security.

# 2. Third FOCUS-Africa Workshop

The Third FOCUS-Africa Workshop is planned to take place in a hybrid mode in South Africa 2022 to bring together the consortium members, close partners, advisory board (AB) members, European Union (EU) officers, and local stakeholders in South Africa and Mauritius to better understand the local needs and requirements for related case studies

in food security and water. The workshop is composed of internal and stakeholder sessions to cover both regional perspectives for the whole project and particularly explore about local gaps, opportunities, and activities in South Africa and Mauritius.

# 3. Objectives

The objectives of the workshop are summarized under two main categories of consortium assembly and stakeholder workshops:

## **Consortium Only Assembly objectives:**

- Increase efficiency in the implementation of the project through face-to-face coordination meetings between all work packages (WPs) and case studies (CSs) partners/ leaders;
- Explore interlinkages and synergies between all different WPs and CSs of the project;
- Explore other possibilities for research and innovation for all WPs and CSs;
- Strengthen collaboration between local partners in the region, particularly in South Africa: WITS, CSIR, ACMAD, University of Cape town, Land Bank.
- Assess synergies with the other projects, such as the H2020 Sister projects (Down2Earth & CONFER) and CLIMSA

- Promote visibility of FOCUS-Africa project by showcasing the progress and challenges of the case studies in South Africa and Mauritius;
- Understand and review users' requirements, perspectives, and strategies for climate services delivery in South Africa and Mauritius;

- Expand the stakeholder network in South Africa and Mauritius;
- Identify risks and lessons learned from 2020/2021 and COVID-19;
- Better understand end-users' requirements;
- Explore the opportunities for capacity building.

#### **Agenda & Speakers**

- Day 1 finalised no speakers need inviting
- Day 2 looks good, in practice may be problematic to split people because of overlaps in CSs
- First day during coffee breaks people can decide how they want to split

- The idea is not to split by CSs but just to split in case we are many people, split in 2 or 3 mixed groups to brainstorm then share in next session back together
- Who would like to talk about nexus and what's most important? WP6 help to steer this discussion? Provide some directions. **Ilaria volunteers as chair**
- Plenary first to get ground rules. Ilaria give presentation in plenary then we go to breakouts with a moderator in each. Ilaria as one, Yasmina, Sara all volunteered
- CSIR preparing delivering to atlas nexus concept, working on that, Shingrai can assist
- Joel Botai SA Weather Service number of projects running focused on this.
   Interesting to share these perspectives. Can also present on nexus at the beginning to kickstart discussion
- **Joel, Shingirai, Ilaria team up to take charge**. Just a question of logistics here so could move things around to allow more time
- **Day 3** TL approached manager and they suggested we asked our executive manager waiting to hear if they are available
- In development by TL, EM, Ilaria, Sara, Yasmina some speakers confirmed with others pending
- Breakout groups are opportunity to get perspective from other food security CSs
- EM communicate with potential speakers specifically on what we expect from them. Dept of Ag has confirmed they will speak. Nehru at Landbank is aware of his presentation
- Content can change slightly according to speakers
- 7 in a panel is too many Francois is part of consortium so could be left out of panel
- Timings Ilaria to make a suggestion in the concept note
- EM & TL if you need formal official letters WMO can prepare those
- Farmers from municipalities put through proposal to support travel and accommodation which has been approved
- Make sure these people are also registered for headcount of numbers
- Day 4 mirroring day 3 except it's a half day, followed by capacity building for met services in PM so no panel discussion. Getting info on user perspective. SG working on this
- ACMAD focus on seasonal forecasting methodologies. Overview on issues related to different aspects, what is used at ACMAD/SACMAD Advantages and disadvantages and discussion with met services on this
- One key thing is to be sure you have enough audience who are we going to have from NHMSs – one participant from each. Waiting for specific nominations but also have short questionnaire to assess their capacities. Also 2 stakeholders from Mauritius

- John didn't make an conscious choice to exclude reanalysis or projections but technical skills will vary so want to avoid too much technicalities. Fully open to tweaking it
- PM leaves out good chunk of people from project they can network or come along to learn
- RB Dragana working on excellent paper on seasonal forecasts, maybe she can also participate. Fine tune it a little bit

## Logistics/venue

- Can't go ahead with CSIR ICC venue moving forward with other options SW and HB have been meeting with other hotels. Likely we will have accommodation and event at same hotel. Negotiating on price, facilities etc currently. Hopefully have venue finalised by Monday
- Possible to cover hybrid element ourselves take laptops to set up virtual meetings then just have cameras and microphones – discuss offline – will need to assign moderators to help out etc
- Covid feedback from Francois, 5<sup>th</sup> wave will coincide with week of workshop, early stages of new peak of variant. Covid protocols upto to venue can't imagine restrictions will be dramatic. Restrictions are being relaxed still. Unlikely that any serious restrictions will be implemented. Be aware that case numbers will be higher than they are currently monitor situation
